

## Non Commercial License for Use of 5Essentials® Survey Content

The University of Chicago licenses the use of the *5Essentials Survey* under a Creative Commons Attribution-Noncommercial 3.0 Unported License (CC BY\_NC 3.0). The CC BY license allows subsequent users to copy, distribute, adapt, and republish the surveys **for noncommercial purposes only, provided they attribute it in the manner specified by The University of Chicago**. Examples of approved and prohibited uses follow. To review the full legal text of the license, see Appendix.

### Approved Uses

This license allows you to use *5Essentials Survey* content for the following purposes **ONLY IF the enterprise is for school improvement or research purposes and NOT a commercial venture**.

- You may conduct surveys of students, teachers or principals in classrooms, schools or districts.
- You may use survey items as content in other surveys.
- You may modify survey items (create Derivative Works) but must accept and agree to be bound by the terms of this license for these Derivative Works and include credit to the University of Chicago Consortium on School Research.

### Prohibited Uses

This license does not entitle any individual or entity to:

- Display *5Essentials Survey* content to the public without including the Required Consortium Citation as given below.
- Claim any *5Essentials Survey* content as their own intellectual property.
- Provide any third party with a license to use *5Essentials Survey* content.
- Use *5Essentials Survey* content without a license.
- Use *5Essentials Survey* content for commercial purposes.

## *Creative Commons Attribution-Noncommercial 3.0 Unported License (CC BY\_NC 3.0)*

The Consortium licenses the use of the *5Essentials*<sup>®</sup> Survey under a Creative Commons Attribution-Noncommercial 3.0 Unported License (CC BY\_NC 3.0). The *5Essentials Surveys* (heretofore referred to as the Work, as defined below) are provided under the terms of this creative commons public license ("ccpl" or "license"). The Work is protected by copyright and/or other applicable law. Any use of the Work other than as authorized under this license or copyright law is prohibited.

By exercising any rights to the Work provided here, you accept and agree to be bound by the terms of this license. To the extent this license may be considered to be a contract, the licensor grants you the rights contained here in consideration of your acceptance of such terms and conditions.

### 1. Definitions

- a. **"Collective Work"** means a work, such as a periodical issue, anthology or encyclopedia, in which the Work in its entirety in unmodified form, along with one or more other contributions, constituting separate and independent works in themselves, are assembled into a collective whole. A work that constitutes a Collective Work will not be considered a Derivative Work (as defined below) for the purposes of this License.
